Small Family Day Care

What is a Small Family Day Care? It means you take care of six and up to eight children in your home if two of the children are at least six years of age.

I have two children of my own under the age of 10 and they stay at home during the time I am providing care to the other children, are they counted as part of the eight children? Yes.

Do I need a permit from the City? No.

Do I need a business license from the City? No.

Do I need any other type of license? Yes. You

need to obtain a license from the State's Department of Social Services. Contact their office at Community Care Licensing, 3737 Main Street, Suite 700, Riverside, CA 92501 (909) 782-4200.

Are there any safety requirements I need to know or must meet? Yes. Contact the Rancho Cucamonga Fire Protection District at City Hall at (909) 477-2770.

What if I want to take care of more than eight children? You need to obtain a Large Family Day Care Permit and a Business License from the City and a Large Family Day Care License from the State's Department of Social Services.

Large Family Day Care

What is a Large Family Day Care? It means you take care of twelve children in your home and up to fourteen children if two of the children are at least six years of age.

I have three children of my own under the age of 10 and they stay at home during the time I am providing care to the other children, are they counted as part of the fourteen children? Yes.

Do I need a permit from the City? Yes. Contact the City's Planning Department at the City Hall at (909) 477-2750.

Do I need a business license from the City? Yes. Contact the City's Business License Department at the City Hall at (909) 477-2700.

Do I need any other type of license? Yes. You need to obtain a license from the State's Department of Social Services. Contact their office at Community Care Licensing, 3737 Main Street, Suite 700, Riverside, CA 92501 (909) 782-4200.

Are there safety requirements I need to know or must meet? Yes, see the attached list of Home Safety Requirements. Contact the Building and Safety Department – New Construction Unit at City Hall at (909) 477-2710 for any questions.

Steps to Obtain a Permit for a Large Family Day Care

1. Contact the City's Planning Department for information and to obtain the application form and filing requirements.
2. While applying for the City's permit, you should also be applying for a license to operate a large family day care with the State's Department of Social Services.
3. Complete the application form and prepare the filing requirements. For example, you have to prepare the mailing address labels for all property owners within a 100-foot radius of your home. If you need help in preparing the filing requirements, please call the Planning staff at the City Hall at (909) 477-2750.
4. Submit the application form, filing requirements, and fee to the Planning Department.
5. Planning staff will review the completeness of the application. If it is found to be complete, staff will send a notice of your proposed large family day care to the surrounding property owners giving them 10 days to respond to the City.
6. A public hearing will not be required unless it is requested by you or one of the surrounding property owners who received the notice.
7. If no response is received, the Planning Director will approve the permit.
8. The decision of the Planning Director is final unless appealed to the Planning Commission within 10 days.
9. Obtain a business license from the City's Business License Department. A fee will be charged.
10. Contact the State's Department of Social Services, Community Care Licensing for an inspection of your home by the State Fire Marshall.

Filing Requirements for a Large Family Day Care Permit

1. Uniform Application form and Large Family Day Care Questionnaire.
2. Four sets of plans consisting of a plot plan and a floor plan on 8 ½ x 11-inch paper. Information on the floor plan must include all applicable items listed on the attached Home Safety requirements.
3. One set of mailing labels listing the name, address, and assessor's parcel number of all property owners within a 100-foot radius of the subject site (measured from your property lines). List shall be obtained from the latest equalized assessment roll issued by the Tax Assessor. For projects located on properties with an Assessor's Parcel Number of **1062-xxx-xx or lower**, contact the Ontario office at: 2314 S. 4. Fee: \$490 (payable at time of submittal).

Home Safety Requirements For Large Family Day Care

- Home must have an R-3 occupancy classification. An approved evacuation plan must be posted.
- Flammable liquids, as per UFC 79.201(e) 2-1 GALLON IN AN APPROVED SAFETY CAN, must be stored in the garage.
- Single station smoke detectors are required between the kitchen and the children's area.
- A 2A10BC fire extinguisher must be conspicuously mounted in the kitchen.
- Provide and maintain a device (not smoke detector) for sounding a fire alarm that is attached to the structure and has a distinctive tone that is audible throughout the house.
- Children may not use rooms located above the first floor except in buildings of Type I or Type II FR construction or in buildings equipped with an automatic fire sprinkler system.
- Garage must be separated by a 1-hour construction, self-closing, solid wood door at least 1 3/8 inch thick.
- All locks must be self-releasing with no key or special knowledge required to operate them. Dead bolts are not permitted on exit doors.
- Two exits are required - no dead bolts, chains, or sliding bolts permitted.
- Exit doors must be no less than 36 feet wide (32 inches clear width) and 6 feet 8 inches high.
- A manually operated horizontal sliding door is acceptable for one exit, if openable from the inside without use of key or special knowledge or effort. It must be 36 inches wide (32 inches clear width).
- It is acceptable to pass through kitchen to exit.
- Table 33-A to be used for multi-storied homes, an exit must be provided from that floor directly to the exterior without entering the first floor.
- Basements must not be used by children unless equipped with exits as approved by the fire department.
- Water hoses must be connected to the front and rear faucets.
- Address must be posted on the house, not the mailbox or curb, with a minimum of 3-inch high numbers in visible contrasting colors.

Information Required on the Floor Plan

1. All applicable items as listed in the Home Safety Requirements for Large Family Day Care (see above).
2. Locations of gas meter, circuit breaker, water heater, forced air unit, and existing smoke detectors.
3. Evacuation routes from the home and designated meeting place where you will count the children after they are evacuated.
